- VIII. **Bombay Fire Department** Mike Dufrane would like to purchase battery operated jaws of life that were used for demos in the amount of \$35,958.40. Pat motions to pay for the purchase, seconded by Sarah. All voted "Aye", motion carried.
- IX. **Building Committee Update** Site work needed at the building, Loran's quote was \$63,480.00. Mike will contact Stephen Rabideau for a quote.
- X. **Assessor** Matthew Szeliga has resigned effective 2/13/24. Vernon Brand will be appointed effective 2/15/24.

IX. Highway Report:

- Truck \$16,099.28 is needed to cover the repairs on the 2011 Truck. Allegiance Truck in Plattsburgh reported that the oil pump suction tube was plugged and that the EGR cooler is leaking and needs replacing. Mike motions to approve the payment, seconded by Pat. All voted "Aye", motion carried. The Board notes that the Highway Maintenance fund will be depleted. Sources of income for the Highway Fund will need to be pursued immediately. It is the opinion of the Board that the Highway Superintendent failed to budget appropriately.
